SUMMARY ANNUAL REPORT FOR AMERICAN AIRLINES-SPONSORED HEALTH AND WELFARE PLANS
(Includes Legacy US Airways plans)

This is the summary annual report for American Airlines, Inc. sponsored health and welfare benefit plans for the plan year January 1, 2021 – December 31, 2021. The annual reports have been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). The following health and welfare benefit plans' annual reports are summarized in this document:

You and your eligible dependents may or may not be participants in one or more of these Plans; therefore, you should check your personal 2021 benefit enrollment records to determine how many and in which of these plans you were enrolled in 2021.

I: American Airlines, Inc. Health and Welfare Plan for Active Employees (#501)

American Airlines has committed itself to pay all self-funded (uninsured) health and dental claims incurred under the terms of the plan.

The plan has contracts with Metropolitan Life Insurance Company, Fidelity Security Life Insurance Company, Life Insurance Company of North America, Kaiser Foundation Health Plan of the Mid-Atlantic, Kaiser Foundation Health Plan of Hawaii, Kaiser Foundation Health Plan, Inc., Triple S Salud, Inc., Community Care HMO, and Humana Health Plans of Puerto Rico, Inc. to pay respectively all life insurance and long term care claims and any insured disability claims, vision insurance claims, accidental death and dismemberment claims, and certain health claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2021 were \$116,331,065.

Because of so called “experience-rated” contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2021, the premiums paid under such “experience-rated” contracts were \$25,008,672 and the total of all benefit claims paid under these experience-rated contracts during the plan year were \$36,064,251.

II: The Supplemental Medical Plan for Employees of Participating American Airlines Group Subsidiaries (#503)

Benefits under the plan are provided on a self-funded (uninsured) basis through Voluntary Employee Benefits Association Trusts (VEBAs).

The value of plan assets, after subtracting liabilities of the plan, was \$124,118,025 as of December 31, 2021, compared to \$110,320,708 as of January 1, 2021. During the plan year the plan experienced an increase in its net assets of \$13,797,317. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan’s assets at the end of the year and the value of the plan’s assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income/(loss) of \$15,809,209, including employee contributions of \$180,530, and earnings from investments of \$15,628,679. Plan expenses were \$2,011,892. These expenses included \$274,434 in administrative expenses and \$1,737,458 in benefits paid to participants and beneficiaries.

III: The American Airlines, Inc. Long Term Disability Plan (#509)

Benefits under the plan are provided on a self-funded (uninsured) basis through a Voluntary Employee Benefits Association Trust (VEBA).

The value of plan assets, after subtracting liabilities of the plan, was \$288,956,151 as of December 31, 2021, compared to \$258,791,699 as of January 1, 2021. During the plan year the plan experienced an increase in its net assets of \$30,164,452. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan’s assets at the end of the year and the value of the plan’s assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income/(loss) of \$42,963,271, including employee contributions of \$6,076,530, and earnings from investments of \$36,886,741. Plan expenses were \$12,798,819. These expenses included \$1,631,331 in administrative expenses and \$11,167,488 in benefits paid to participants.

IV: TWA Retiree Health and Life Benefits Plan (#511)

American Airlines has committed itself to pay certain self-funded (uninsured) health claims incurred under the terms of the plan while other health benefits under the plan are provided on a self-funded (uninsured) basis through a Voluntary Employee Benefits Association Trust (VEBA).

The plan has a contract with Metropolitan Life Insurance Company to pay all life insurance claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2021 were \$4,132,559. Because it is a so called “experience-rated” contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2021, the premiums paid under such “experience-rated” contract were \$4,132,559 and the total of all benefit claims paid under the experience-rated contract during the plan year were \$3,681,212.

The value of plan assets, after subtracting liabilities of the plan, was \$1,647,310 as of December 31, 2021, compared to \$1,404,185 as of January 1, 2021. During the plan year the plan experienced an increase in its net assets of \$243,125. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan’s assets at the end of the year and the value of the plan’s assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$7,730,286, including employer contributions of \$5,327,748, employee contributions of \$2,402,131, and earnings from investments of \$407. Plan expenses were \$7,487,161. These expenses included \$324,967 in administrative expenses and \$7,162,194 in benefits paid to participants and beneficiaries.

V. American Airlines, Inc. Pilot Long Term Disability Plan (#513)

American Airlines has committed itself to pay all self-funded (uninsured) long term disability claims incurred under the terms of the plan.

Additional Explanation: The plan is 100% funded by American Airlines, Inc. corporate assets—employees do not make contributions for coverage under the plan. The plan became effective on February 1, 2004, in accordance with the collective bargaining agreement between American Airlines, Inc. and the Allied Pilots Association and closed to new entrants effective September 30, 2012.

VI. American Airlines, Inc. Life and Health Benefits Plan for Retirees (#515)

American Airlines has committed itself to pay certain self-funded (uninsured) health claims incurred under the terms of the plan while other health claims under the plan are provided on a self-funded (uninsured) basis through Voluntary Employee Benefits Association Trusts (VEBAs).

The plan has contracts with Metropolitan Life Insurance Company to pay all life insurance claims and with Triple S Salud, Inc. to pay certain health claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2021 were \$5,569,301. Because they are so called “experience-rated” contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2021, the premiums paid under such “experience-rated” contracts were \$5,569,301 and the total of all benefit claims paid under these experience-rated contracts during the plan year were \$8,625,974.

The value of plan assets, after subtracting liabilities of the plan, was \$169,117,858 as of December 31, 2021, compared to \$170,356,582 as of January 1, 2021. During the plan year the plan experienced a decrease in its net assets of (\$1,238,724). This decrease includes unrealized appreciation and

depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the plan's assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$31,290,859, including employer contributions of \$6,291,527, employee contributions of \$3,101,893, and earnings from investments of \$21,897,439. Plan expenses were \$32,529,583. These expenses included \$3,836,234 in administrative expenses and \$28,693,349 in benefits paid to participants and beneficiaries.

VII. American Airlines, Inc. 2012 Pilot Long Term Disability Plan (#516)

American Airlines has committed itself to pay all self-funded (uninsured) long term disability claims incurred under the terms of the plan.

Additional Explanation: The plan is 100% funded by American Airlines, Inc. corporate assets—employees do not make contributions for coverage under the plan. The plan became effective on October 1, 2012, in accordance with the collective bargaining agreement between American Airlines, Inc. and the Allied Pilots Association.

VIII. American Airlines, Inc. Health Benefits Plan for Certain Legacy Employees (#517)

American Airlines has committed itself to pay certain self-funded (uninsured) health and dental claims incurred under the terms of the plan.

The plan has contracts with Unum Life Insurance Company of America to pay long term care insurance and Fidelity Security Life Insurance Company to pay vision insurance claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2021 were \$341,244.

Because it is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2021, the premiums paid under such "experience-rated" contract were \$341,244 and the total of all benefit claims paid under the experience-rated contract during the plan year were \$0.

IX. American Airlines, Inc. Group Life and Disability Plan for Certain Legacy Employees (#518)

The plan has contracts with Metropolitan Life Insurance Company to pay long term disability, accidental death and dismemberment, and life insurance claims incurred under the terms of the plan. Total premiums paid for the plan year ending December 31, 2021 were \$57,079.

X. American Airlines, Inc. Pilot Disability Plan for Certain Legacy Pilots (#521)

American Airlines has committed itself to pay certain self-funded (uninsured) long term disability claims incurred under the terms of the plan.

The value of plan assets, after subtracting liabilities of the plan, was \$43 as of December 31, 2021, compared to \$43 as of January 1, 2021. During the plan year there was no change in net assets. During the plan year, the plan had total income of \$5,339,091, including employer contributions of \$5,338,592 and earnings from investments of \$499. Plan expenses were \$5,339,091. These expenses included \$142,520 in administrative expenses and \$5,196,571 in benefits paid to participants.

XI. American Airlines, Inc. DFW ConnectedCare Plan (#523)

American Airlines has committed itself to pay all self-funded (uninsured) medical claims incurred under the terms of the plan.

XII. American Airlines, Inc. Long Term Disability Plan for TWU-IAM Employees (#524)

The plan has contracts with Metropolitan Life Insurance Company to pay long term disability claims incurred under the terms of the plan. Total premiums paid for the plan year ending December 31, 2021 were \$13,047,540.

XIII. American Airlines, Inc. Retiree Health Reimbursement Arrangement Plan (#525)

American Airlines has committed itself to pay all eligible medical reimbursement claims under the terms of the plan.
